### **SUPPLY AGREEMENT WITH TEAMS**

Pirelli Japan K.K. ("PIRELLI") and Team hereby agreed this Supply Agreement with Teams ("Contract") as follows:

1. Mobilityland Corporation ("Promoter") has selected PIRELLI as an official exclusive supplier for the tyres which will be supplied for all Teams ("TYRE") in the event ("Event") as described in attached Appendix.

2. Trofeo5 K.K. on behalf of PIRELLI should be a seller of TYRE to Team in the Event.

3. TEAM has to place its order for the TYRES to Trofeo5 K.K. no later than 23:59 on 7, 29 2018. A 20% fee for late orders will be applied per each tyre ordered after this date.

4. TEAM shall pay 20 sets of purchase order in (Official Practice + Qualify + Super Pole + Race tyre)+ the number of (Paid Practice) order in advance, (no later than 7, 29 2018, after which date a 20% late order fee applies) to Trofeo5 K.K. before the Event. PIRELLI allows TEAM to return only TYRE which TEAM does not assemble wheel rim and use then PIRELLI will refund price of TYRE after subtracting handling fee. However, PIRELLI may inspect the returned TYRE by technical point of view and reject to accept return when PIRELLI judges the TYRE is damaged. TEAM may not make a protest the judgement. TEAM shall report actual number of TYRE which TEAM uses during the Event and shall return TYRE which TEMA does not assemble rim and use after the Event. In a case when TEAM still has an outstanding account after adjustment, TEAM shall pay the bill from Trofeo5 K.K. no later than the last day of the following month of billing date.

7. Any press release relating to this Contact or the termination thereof shall be previously agreed upon between the Parties.

14. TEAM may not assign or otherwise transfer this Contract to third parties, in whole or in part, without PIRELLI's express previous written consent. PIRELLI may freely assign or transfer this Contract to any of its Affiliates.

15. Any amendment to this Contract shall be made in writing and signed by person or persons duly authorized to undertake obligation on behalf of the parties.
